Foot Path Repairs



The HOA has been in frequent communication with the City of Livermore regarding the status of repairs to the foot path along the arroyo that was washed out this winter. The city will be repairing damage between Concannon Blvd. and Stanley Blvd. The city expects to begin repairs in our area in September. More details will be provided when they become available.

Zone 7 Arroyo-Medeiros Parkway Project

The Zone 7 Water Agency, which manages our water in Livermore, is working with the City of Livermore to make improvements along the arroyo that backs onto our neighborhood. The so-named Arroyo-Medeiros

Parkway Project extends from Arroyo Rd. to Stanley Blvd. along the arroyo stream, and has the primary intent of reducing flood impact along the stream, but will also put effort into environmental restoration in encouraging native plants and removing invasive plants which can add fuel to fires. Construction is scheduled to begin in 2019.



Overall jurisdiction and management of the arroyo lands will be shared between Zone 7 and the City of Livermore, where Zone 7 will develop flood controls and promote native plants, while the City is primarily responsible for law enforcement and fire control.

Several of our neighbors attended a public information meeting on the project on July 19th and raised concerns of fire, transient encampments and land use. Zone 7 employees took notes and will consider all concerns as planning goes forward. More public information meetings will be scheduled and all are encouraged to attend.
