Island Renovation

There is an active committee (Judy Mackanic is the lead), and their task is to provide a vision for revitalizing the landscaping on our islands. Progress is slow as it has been very hard to get responses from various contractors. The first step is an evaluation of our heritage trees in the islands and common area from a certified horticulturist, which should occur in October, to determine their current health and how to best care for them in the future. The committee has also identified a landscape designer to work with for the design that is both beautiful and drought resistant. It is expected to have plans next Spring, then renovation activity can start in budget-friendly phases.

CC&Rs and Bylaws



Almost 50% of the households responded to the survey; thank you for the input! Based on your responses, we will base the update on the existing governing documents to make them more useable and up to date. Two additional topics received broad (>75%) support: restricting short term (<30 days) rentals and controlling storage of items that are visible from the street.

Tree Removal and Replacement

- Removal of heritage trees on private property require a City of Livermore Permit. Their policy of tree removal is defined on the city website.
- Licensed arbor companies usually will facilitate obtaining the tree removal permit, but it is up to the homeowner on the choice of its replacement.
- Great news: the FGE HOA, in an effort to promote our forest-like namesake, will rebate \$200 per replacement tree in keeping with maintaining our image. The tree needs to reach a mature height of at least 40 feet. Ideally, the tree is also on the recommended city list, native, and zoned appropriately.

(If you need help, Renee has the city list and some retail resources).



Reminder - Drive Carefully!

Our neighborhood streets are curvaceous and narrow in spots. Slow down, watch for pedestrians (young and old). Stay to the right side of the road and within the appropriate street markings and signs. Also street parking is permitted only on the sidewalk side of the road. Enjoy the beauty of our neighborhood and be safe.
