Island Renovation

So far, the progress we've made on the island renovation committee is:



Hired a certified arborist to evaluate the trees - we've received the report which states that overall, our trees are in good shape and have begun implementing some of the recommendations to keep them healthy, such as cabling one of the trees and trimming an overhanging branch from the same tree.

We have contracted with Eric Teberg to develop a unified plan for renovating the islands. One benefit of Eric's approach is we will be able to address each island individually as resources allow. More details of the planned island renovation will be shared at the Summer BBQ in June.

CC&Rs and Bylaws



A new revision based upon the existing governing documents is a work in process. The next task is to rewrite the existing CCRs to: 1) eliminate the text that is no longer applicable, and 2) adjust a couple of articles, e.g., restricting short-term rentals, based on the survey feedback in Fall 2023.

Financial Reserve Study



We mentioned in the last newsletter that to comply with CA regulations, we engaged with a company to evaluate our financial responsibility in maintaining the common area and associated assets (trees, irrigation system, tennis courts and hardware) and create a 30-year plan for what we should have in financial reserves to cover repair and replacement costs. maintaining these assets and do a bit less "fix on failure". The plan is complete and it will be part of the budget
